 end of September. Urgent nominations will be called for Vice President, to take over the
 role of President next year. John Michell that a Nomination for Vice President should be
 called for at the next General Meeting. This should be advertised in the Newsletter prior to
 the meeting.
- Update on vacant positions Vice President is a position to be added to the other vacant convenors, International Tours & Theatre Parties.
- Discuss how the committee is running do we need to make any improvements?
 Bev is to email all Committee Members distributing all email addresses as per action above reinforcing Aldo's previous request that all reports should be sent to all committee members 3 days prior to the Committee Meeting.
- Responsibility for custody of defibrillator during Aldo's absence.
 Bev Rooney is to be the custodian of the defibrillator, bringing it to meetings & providing as requested.
- Update on air travel with defibrillator-John Perry. John has investigated the situation with
 defibrillators & ascertained that Deep Cell Battery Defibrillators cannot travel on a plane.
 Ordinary defibrillators are allowed with the permission of the airline, but in his attempt to
 contact Virgin, he was advised that it would take the format of a legal form, the initial cost
 of which was \$66.00 to apply. As a result of John's enquiries, the Committee took the
 decision of not attempting to take the defibrillator on future air tours.
